## 5. Action

5.1. Discuss, consider and take all necessary action with regard to a real estate purchase and sale agreement to purchase real property located near North 33rd and Lincoln Streets, and the issuance of lease revenue bonds to acquire, construct, and furnish a new elementary school building and equipment and related matters, and a lease agreement with Beatrice Public Schools for the elementary school facility and related matters

Mike Rogers with Gilmore Bell informed the Board that a real estate purchase agreement is necessary because the SNEA has the power to mortgage property. He informed the Board that an administrative subdivision of the property was recently completed to create this new lot (28.42 acres) and that the Board of Education approved selling the land and appropriating the funds for such at their meeting on June 13, 2022. Next, Colleen Duncan with Gilmore Bell spoke about the issuance of bonds for the SNEA to secure financing for the project. She informed the Board that the proposed resolution will formally authorize the issuance of lease rental revenue bonds. She explained the terms and how it will work through an executive summary that was provided to all Board members. She highlighted some of the other documentation that is part of the resolution as well as the lease agreement with the school district. Paul Grieger of DA Davidson explained the draw down system and debt service for the SNEA as currently estimated. He noted that the offer from Pinnacle Bank was incredibly fair. Mr. Alexander provided an update on the district's budget and how the lease payments will be made. He also shared an update on the design process. The closing process was outlined by Gilmore Bell and a brief discussion ensued.

I move that the Board of Directors for the Southeast Nebraska Education Agency approves purchase of the real property from the seller, and the issuance of bonds to acquire, construct, and furnish a new elementary school building, and a lease agreement with Beatrice Public Schools for such facility and that the Board hereby approves and adopts the attached resolution passed with a motion by Brenda A McNiff and a second by Jan Reimer.
